Formulary Polysulfide Toner is a brown toner similar to Kodak T-8. The toning bath contains potassium polysulfide (liver of sulfur) and sodium carbonate as an alkali. Formulary Polysulfide Toner, like Hypo-Alum Sepia Toner, deposits silver sulfide on the image. The difference between the two toners is the depth of the brown color that results. Polysulfide Toner gives a rich, dark-brown tone while tones obtained using the Hypo-Alum toner are much lighter. Both toners give permanent images.
